In the event that MHR is required to take action to enforce the provisions of this agreement whether through litigation or otherwise, Borrower agrees to reimburse MHR for its reasonable attorney's fees, collection costs and expenses incurred in enforcing the agreement.
- 4 This agreement contains the entire understanding of the parties with respect to its subject matter.
